

# 718 - Texas A&M University at Galveston

Workforce Summary Document Prepared by the State Auditor's Office.  
Based on a review of information self-reported by the institution, the following items are worth noting.

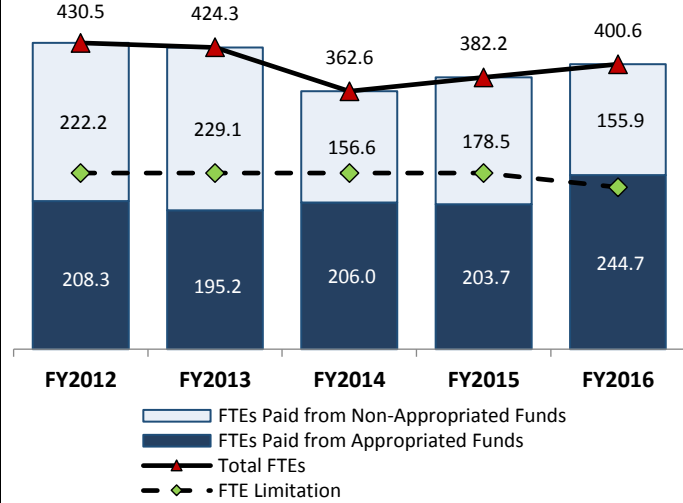
## Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation decreased by 8.1 percent to 227.6 FTEs in fiscal year 2016 compared to fiscal year 2015. As of August 31, 2016, 5.6 FTEs were administrator positions. The institution's 400.6 total FTEs represents a decrease of 29.9 (6.9 percent) in the total number of FTEs since fiscal year 2012.

In fiscal year 2016, 38.9 percent of FTEs were paid from non-appropriated funds. This is a decrease of 29.8 percent in FTEs paid from non-appropriated funds since fiscal year 2012. Only FTEs paid from appropriated funds count against the FTE limitation.

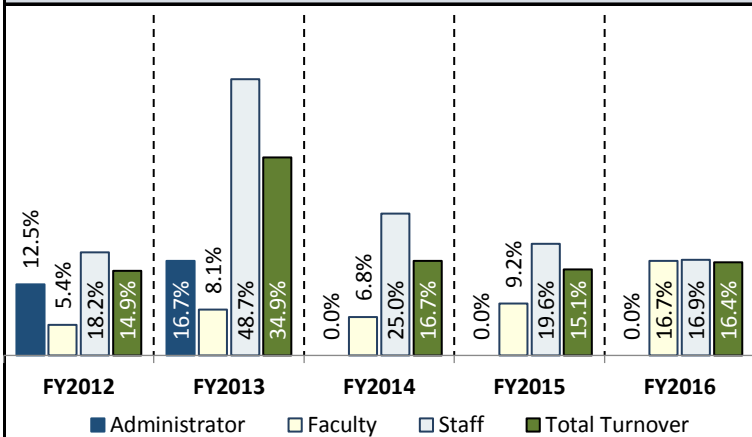

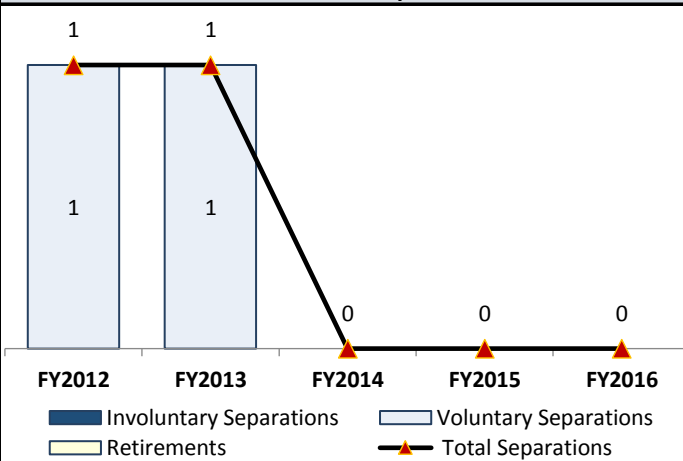
## Employee Turnover<sup>a</sup>

In fiscal year 2016, the total turnover rate for the institution was 16.4 percent. This was higher than in fiscal year 2015, when the total turnover rate was 15.1 percent. The turnover rate in fiscal year 2016 for administrators (0.0 percent) was the same as fiscal year 2015, turnover for faculty positions (16.7 percent) was higher than in fiscal year 2015, and turnover for staff positions (16.9 percent) was lower than in fiscal year 2015.

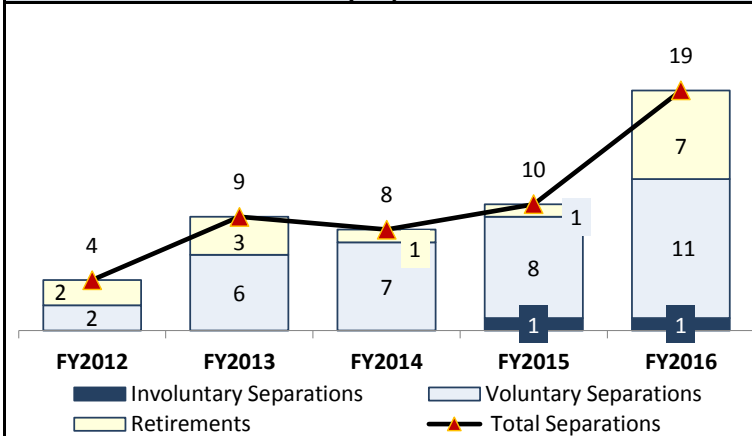
### Turnover Rates



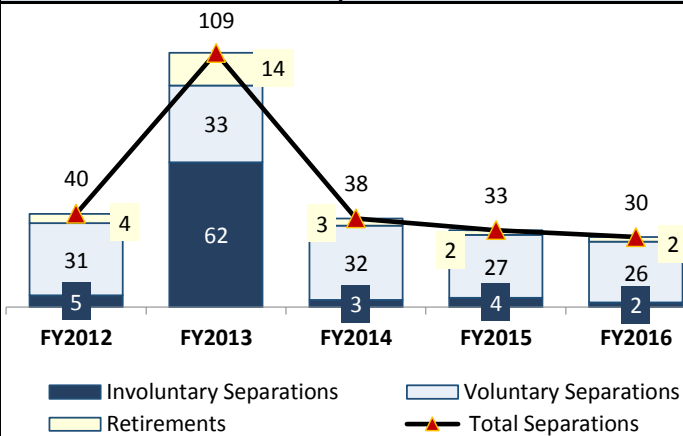
### Administrator Separations

<sup>a</sup> Turnover information is self-reported by the institution. Administrator positions include officials holding titles such as president, vice president, chancellor, associate chancellor, assistant chancellor, dean, associate dean, assistant dean, and positions with similar responsibilities. Faculty positions include all faculty regardless of tenure or benefits eligibility. Staff positions include only non-faculty employees who worked at least 20 hours per week for at least 4.5 months.

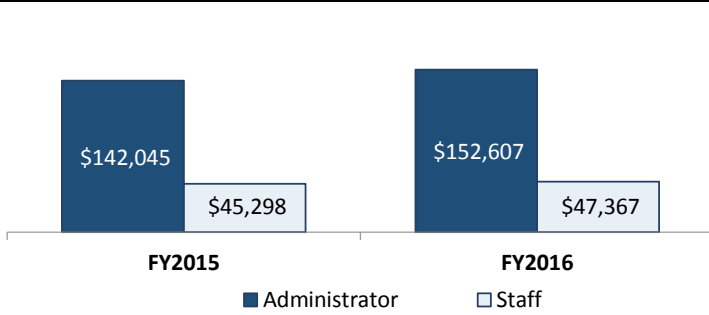
<sup>b</sup> In fiscal year 2013, Texas A&M University at Galveston outsourced its food services and facilities functions. As a result, employment for staff workers in those functions was terminated, resulting in a large number of involuntary separations in fiscal year 2013.

## Compensation Information <sup>c</sup>

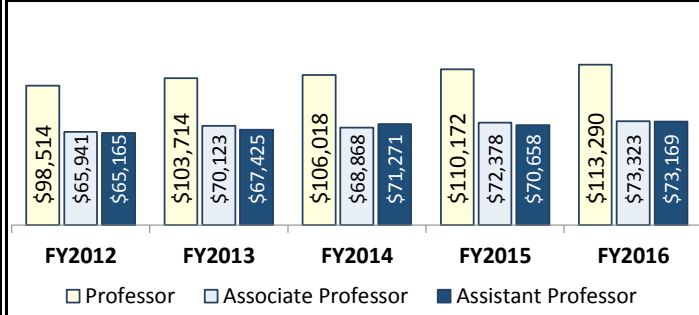
The average salary for staff employees increased by 4.6 percent and for administrators it increased by 7.4 percent when compared to the average salaries in fiscal year 2015. Compared to fiscal year 2012, salary and benefits expenditures increased by 36.9 percent.

In fiscal year 2016, the chief operating officer's salary was \$231,591. This salary increased from fiscal year 2015, when the chief operating officer's salary was \$227,049.

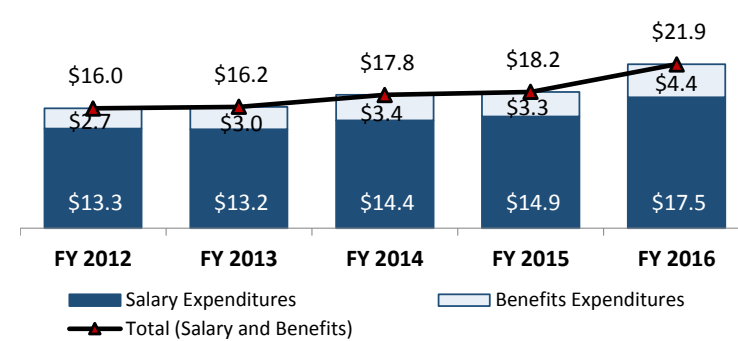
### Administrator and Staff Average Salaries

In fiscal year 2016, the institution used appropriated funds to pay for 80.2 percent of administrator merit increases, 90.4 percent of faculty merit increases, and 72.7 percent of staff merit increases.

## Fiscal Year 2016 Workforce Demographics and Veteran Workforce Analysis <sup>c d</sup>

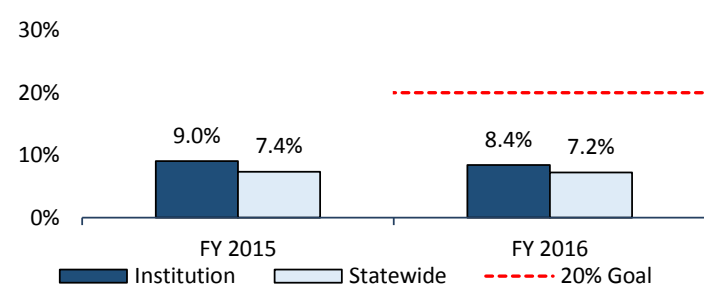
Of the institution's administrators, 100.0 percent were 40 years of age or older, and of the institution's staff employees, 56.2 percent were 40 years of age or older. The average length of employment at the institution for administrators was 20.1 years, and for staff employees it was 5.6 years.

Senate Bill 805 (84th Legislature) amended Texas Government Code, Section 657.004, to set a goal for higher education institutions of employing veterans in full-time positions equal to at least 20.0 percent of the total number of institution employees effective September 1, 2015.

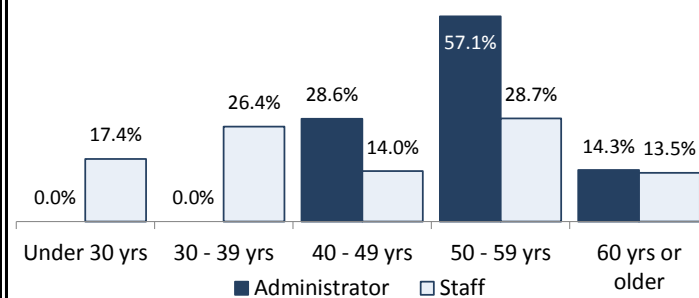
In fiscal year 2016, the institution's total percentage of veterans employed is higher than the state average and has decreased since fiscal year 2015.

In fiscal year 2016, 48.2 percent of faculty FTEs with teaching responsibility were tenured or tenure-track.

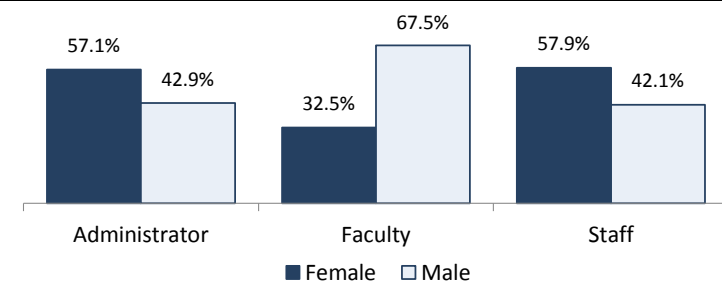
### Veteran Employment



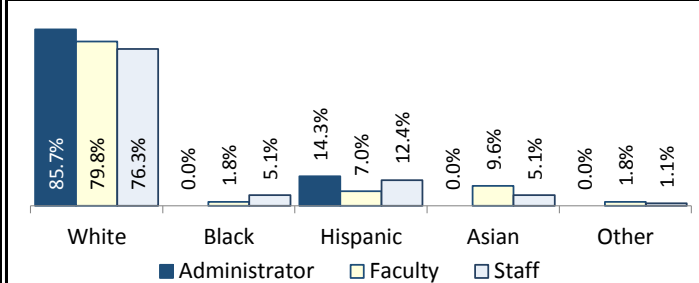
### Age: Administrator and Staff
