

# 749 - Texas A&M University - San Antonio

Workforce Summary Document Prepared by the State Auditor's Office.  
Based on a review of information self-reported by the institution, the following items are worth noting.

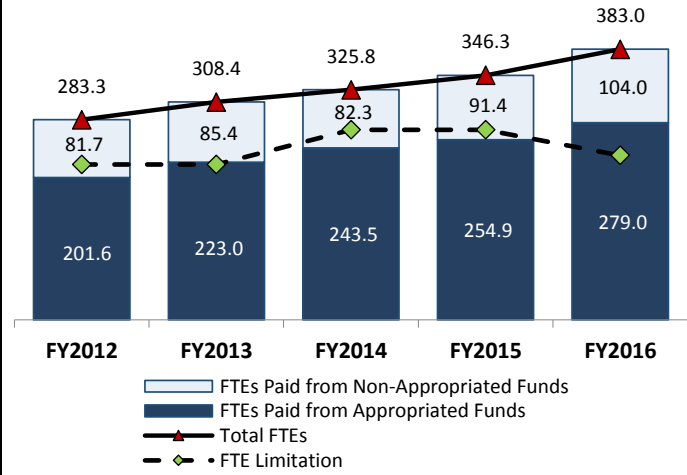
## Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation decreased by 13.4 percent to 232.9 FTEs in fiscal year 2016 compared to fiscal year 2015. As of August 31, 2016, 10.5 FTEs were administrator positions. The institution's 383.0 total FTEs represents an increase of 99.7 (35.2 percent) in the total number of FTEs since fiscal year 2012.

In fiscal year 2016, 27.2 percent of FTEs were paid from non-appropriated funds. This is an increase of 27.3 percent in FTEs paid from non-appropriated funds since fiscal year 2012. Only FTEs paid from appropriated funds count against the FTE limitation.

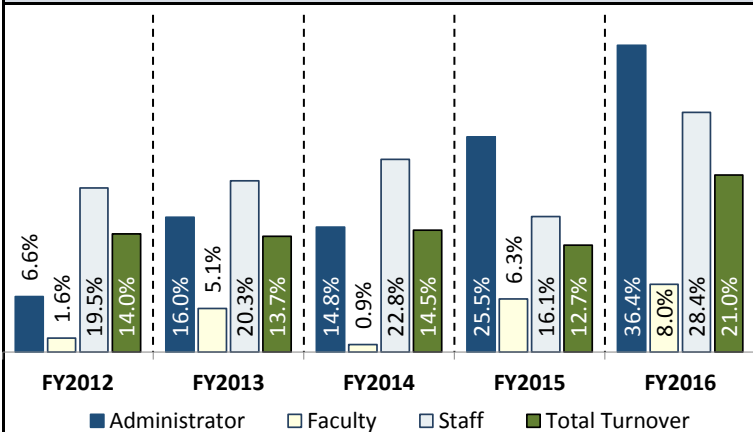

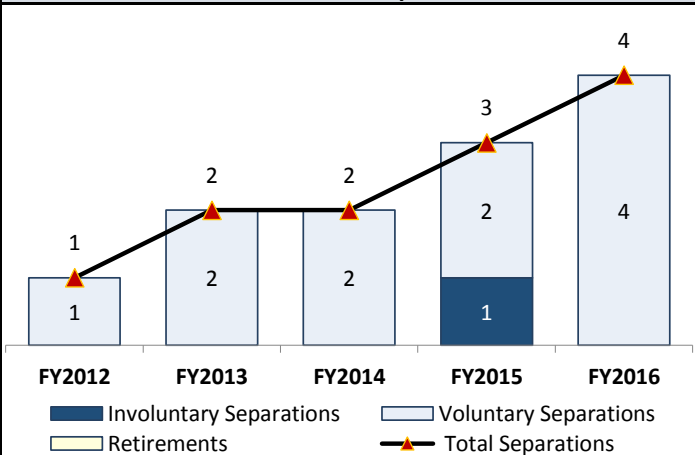
## Employee Turnover<sup>a</sup>

In fiscal year 2016, the total turnover rate for the institution was 21.0 percent. This was higher than in fiscal year 2015, when the total turnover rate was 12.7 percent. The turnover rate in fiscal year 2016 for administrators (36.4 percent) was higher than in fiscal year 2015, turnover for faculty positions (8.0 percent) was higher than in fiscal year 2015, and turnover for staff positions (28.4 percent) was higher than in fiscal year 2015.

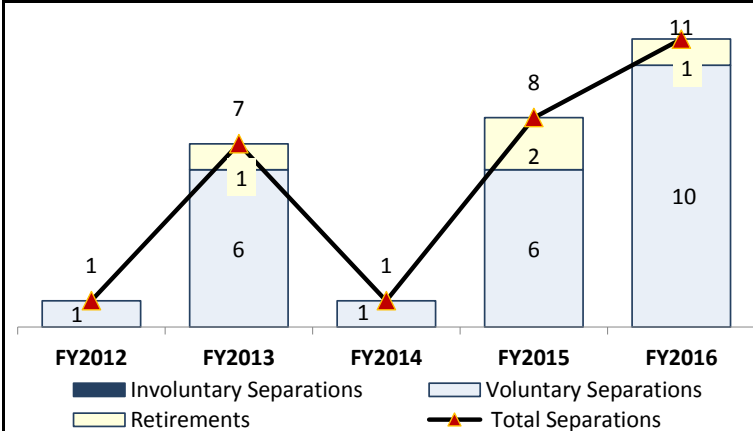
### Turnover Rates



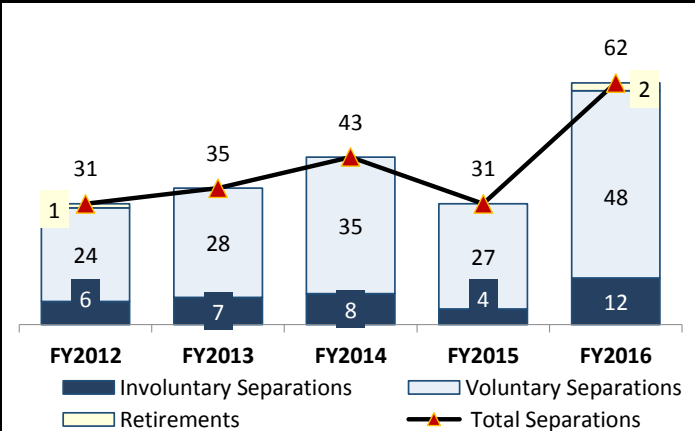
### Administrator Separations

### Staff Separations



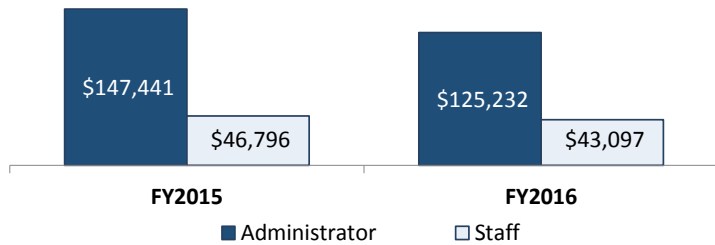

Faculty positions include all faculty regardless of tenure or benefits eligibility. Staff positions include only non-faculty employees who worked at least 20 hours per week for at least 4.5 months.

## Compensation Information <sup>b</sup>

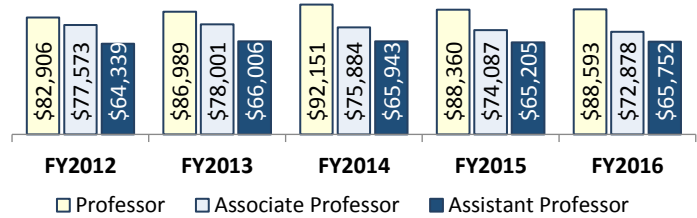
The average salary for staff employees decreased by 7.9 percent and for administrators it decreased by 15.1 percent when compared to the average salaries in fiscal year 2015. Compared to fiscal year 2012, salary and benefits expenditures increased by 57.6 percent.

In fiscal year 2016, the president's salary was \$274,701. This salary increased from fiscal year 2015, when the president's salary was \$266,701.

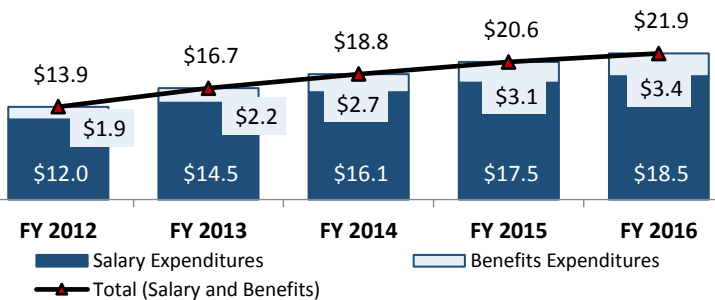
### Administrator and Staff Average Salaries

In fiscal year 2016, the institution used appropriated funds to pay for 100.0 percent of administrator merit increases, 100.0 percent of faculty merit increases, and 68.0 percent of staff merit increases.

## Fiscal Year 2016 Workforce Demographics and Veteran Workforce Analysis <sup>b c</sup>

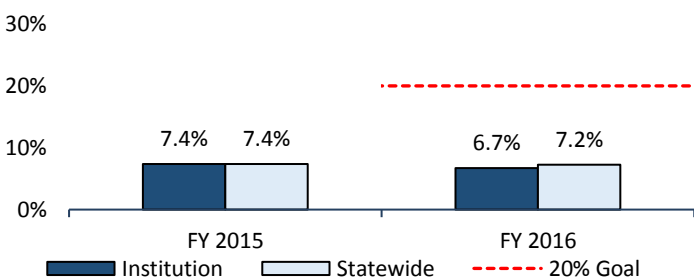
Of the institution's administrators, 100.0 percent were 40 years of age or older, and of the institution's staff employees, 51.7 percent were 40 years of age or older. The average length of employment at the institution for administrators was 3.4 years, and for staff employees it was 3.0 years.

Senate Bill 805 (84th Legislature) amended Texas Government Code, Section 657.004, to set a goal for higher education institutions of employing veterans in full-time positions equal to at least 20.0 percent of the total number of institution employees effective September 1, 2015.

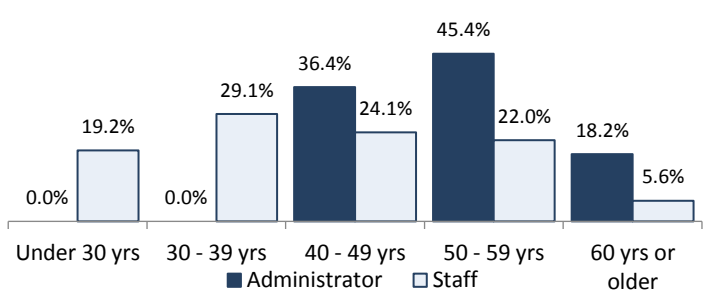
In fiscal year 2016, the institution's total percentage of veterans employed is lower than the state average and has decreased since fiscal year 2015.

In fiscal year 2016, 52.0 percent of faculty FTEs with teaching responsibility were tenured or tenure-track.

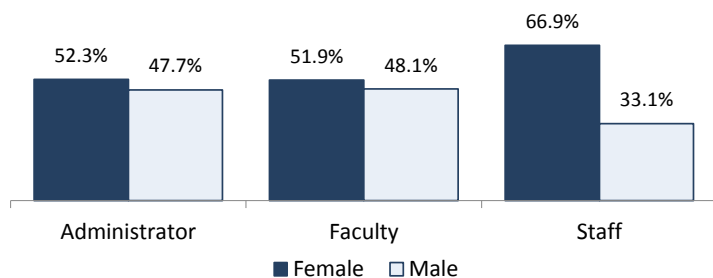
### Veteran Employment



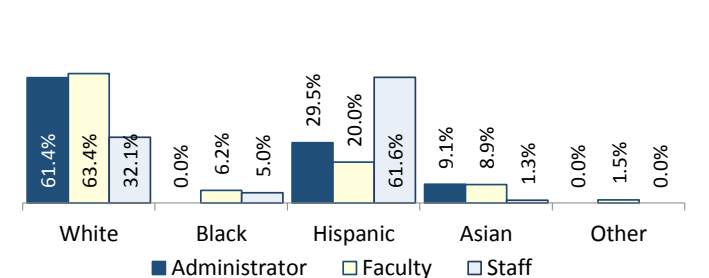
### Age: Administrator and Staff

Faculty positions include all faculty, regardless of tenure or benefits eligibility. Staff positions include only non-faculty employees who worked at least 20 hours per week for at least 4.5 months.
