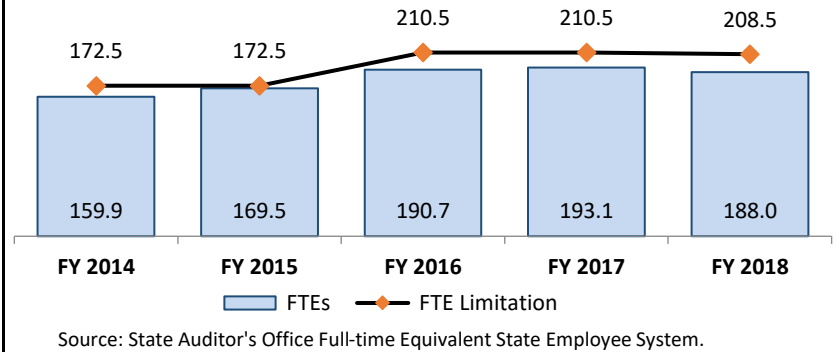
Workforce Summary Document prepared by the State Auditor's Office.
Based on information self-reported by the agency, the following items are noteworthy.

Full-Time Equivalent (FTE) Employees

The agency's full-time equivalent (FTE) employee limitation decreased by 1.0 percent to 208.5 FTEs in fiscal year 2018 compared to fiscal year 2017. Compared to fiscal year 2014, the agency had an increase of 28.1 (17.6 percent) in the total number of FTEs.

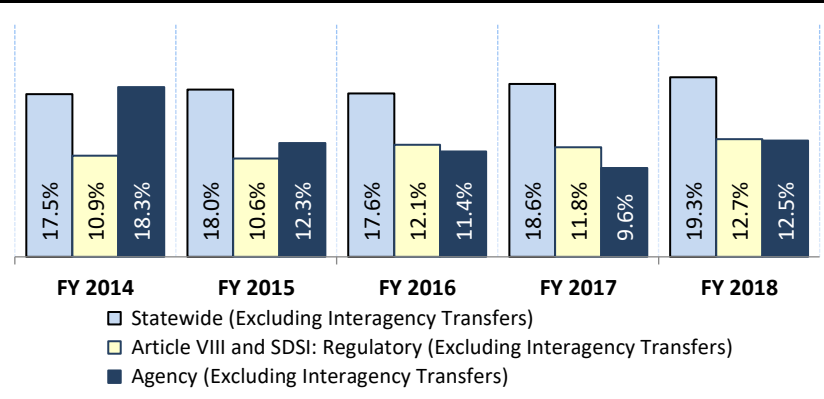
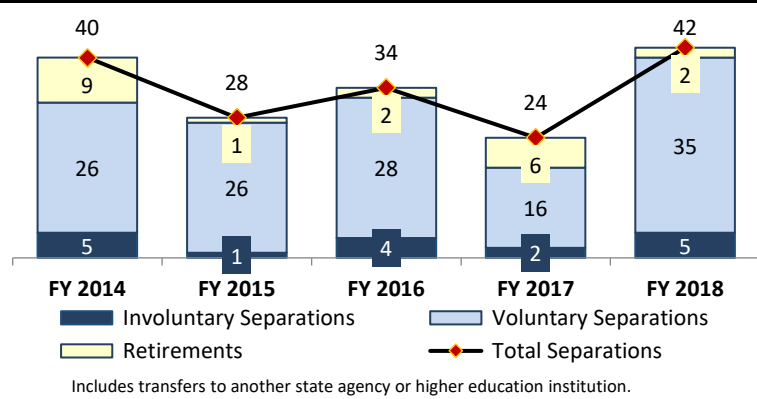

Employee Turnover ^a

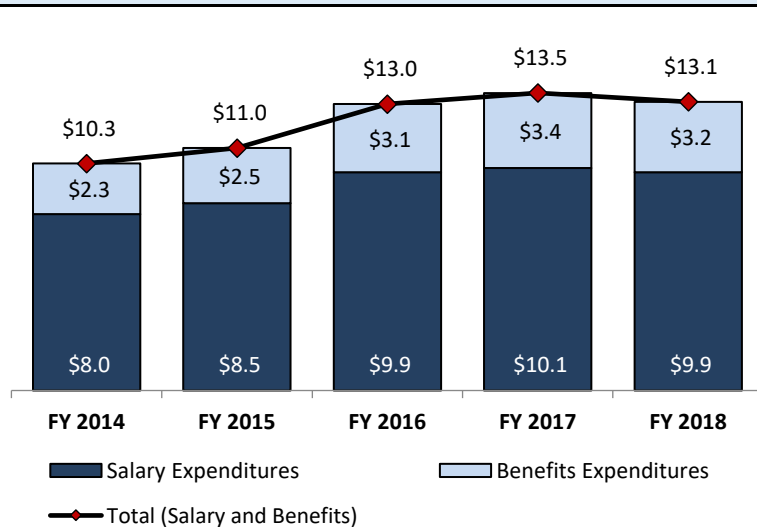
Excluding interagency transfers, the turnover rate within the agency (12.5 percent) was lower than the statewide turnover rate (19.3 percent) and lower than the turnover rate of Article VIII and Self-Directed, Semi-Independent (SDSI) agencies (12.7 percent) during fiscal year 2018. The fiscal year 2018 agency turnover rate including employees who transferred to another state agency or higher education institution was 21.0 percent.



Compensation Information ^a

The average agency salary of \$50,038 in fiscal year 2018 represented an increase of 8.0 percent compared to the average agency salary in fiscal year 2014. In fiscal year 2018, 92.8 percent of employees were paid below the midpoint of the salary range in which they were assigned. Total agency expenditures for salary and benefits were higher compared to fiscal year 2014.

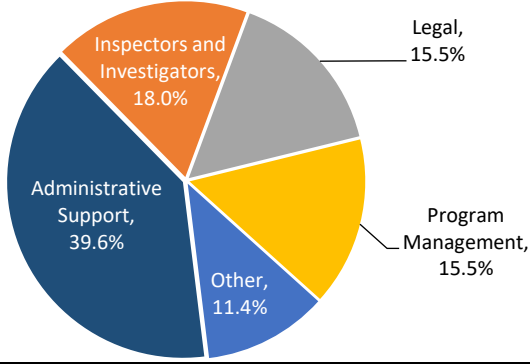

Fiscal Year 2018 Major Occupational Categories



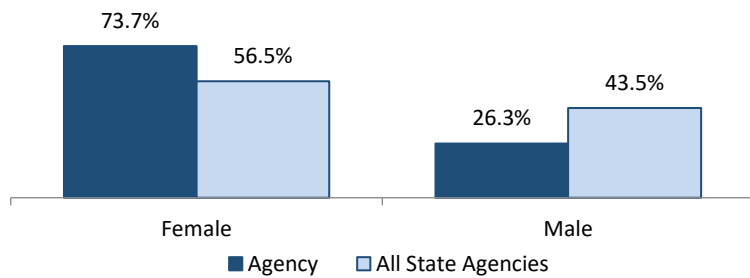
Agency Job Classifications

In fiscal year 2018, the majority (79.7 percent) of employees were classified in the following job titles: License and Permit Specialist (22.4 percent), Investigator (18.0 percent), Administrative Assistant (15.4 percent), Attorney (7.0 percent), Program Specialist (6.5 percent), Legal Assistant (5.4 percent), and Manager (5.0 percent).

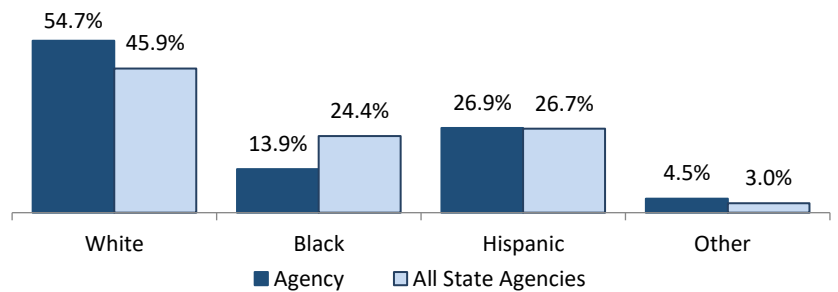
Fiscal Year 2018 Workforce Demographics ^b

On average, employees at the agency were 46.1 years of age and had 5.8 years of agency length of service. Of the agency's employees, 66.2 percent were 40 years of age or older, and 58.6 percent had fewer than 5 years of agency length of service. The Employees Retirement System estimates that between fiscal years 2018 and 2022, 13.7 percent of the agency's workforce will be eligible to retire (based on fiscal year 2018 data).

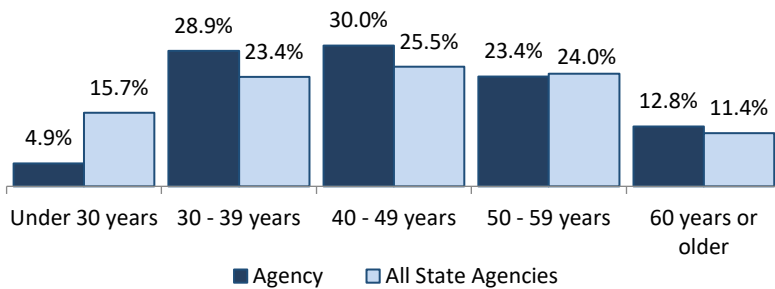
Gender



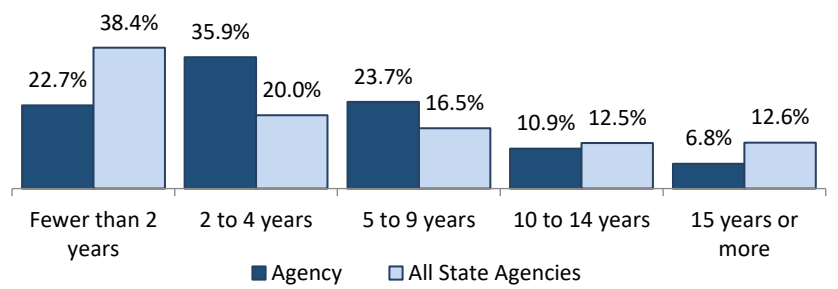
Ethnic Group

Agency Length of Service

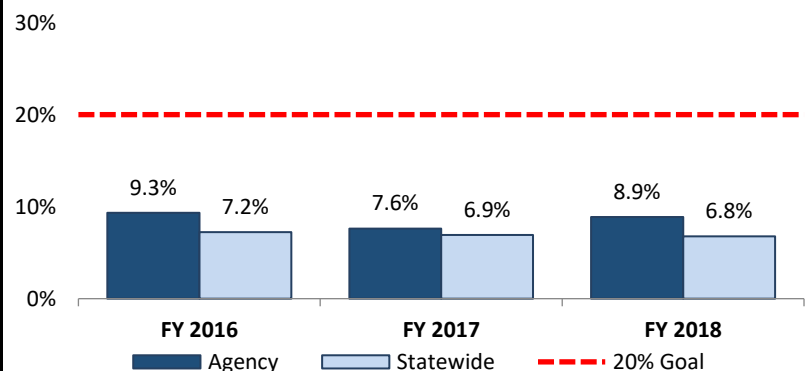

Veteran Employment ^c

Effective fiscal year 2016, Texas Government Code, Section 657.004, sets for state agencies a goal of employing veterans in full-time positions equal to at least 20.0 percent of the total number of agency employees.

In fiscal year 2018, the agency's total percent of veterans employed was higher than the statewide average and had increased since fiscal year 2017.
