

Full-Time Equivalent (FTE) Employees


The agency's full-time equivalent (FTE) employee limitation decreased by 7.1 percent to 13.0 FTEs in fiscal year 2020 compared with fiscal year 2019. Compared with fiscal year 2016, the agency had a decrease of 1.6 (12.6 percent) in the total number of FTEs.



Employee Turnover ^a


Excluding interagency transfers, the turnover rate within the agency (19.0 percent) was higher than the statewide turnover rate (18.6 percent) and higher than the turnover rate of Article I agencies (9.0 percent) during fiscal year 2020. The fiscal year 2020 agency turnover rate including employees who transferred to another state agency or higher education institution was 19.0 percent.





Compensation Information ^a

The average agency salary of \$74,905 in fiscal year 2020 represented an increase of 40.3 percent compared with the average agency salary in fiscal year 2016. In fiscal year 2020, 69.0 percent of employees were paid below the midpoint of the salary range in which they were assigned. Total agency expenditures for salaries and benefits were higher compared with fiscal year 2016.







During the past two years, this agency was not selected as part of our office's classification compliance audits.


Fiscal Year 2020 Workforce Demographics c
