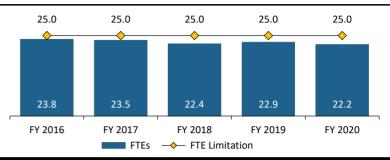

#### Full-Time Equivalent (FTE) Employees

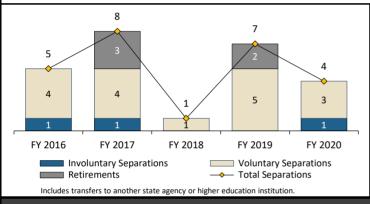
The agency's full-time equivalent (FTE) employee limitation remained the same in fiscal year 2020 compared with fiscal year 2019. Compared with fiscal year 2016, the agency had a decrease of 1.6 (6.7 percent) in the total number of FTEs. In fiscal year 2020, the agency employed 0.3 federally funded FTEs, which do not count toward the limitation.

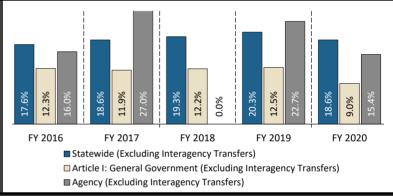

# **Employee Turnover** <sup>a</sup>

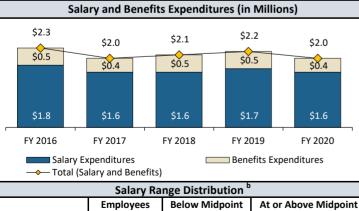
Excluding interagency transfers, the turnover rate within the agency (15.4 percent) was lower than the statewide turnover rate (18.6 percent) and higher than the turnover rate of Article I agencies (9.0 percent) during fiscal year 2020. The fiscal year 2020 agency turnover rate including employees who transferred to another state agency or higher education institution was 20.5 percent.





### Compensation Information <sup>a</sup>

The average agency salary of \$75,233 in fiscal year 2020 represented an increase of 15.5 percent compared with the average agency salary in fiscal year 2016. In fiscal year 2020, 89.2 percent of employees were paid below the midpoint of the salary range in which they were assigned. Total agency expenditures for salaries and benefits were lower compared with fiscal year 2016.

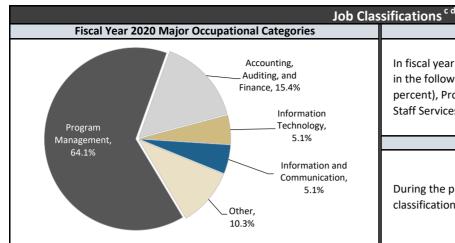

#### **Agency Job Classifications**

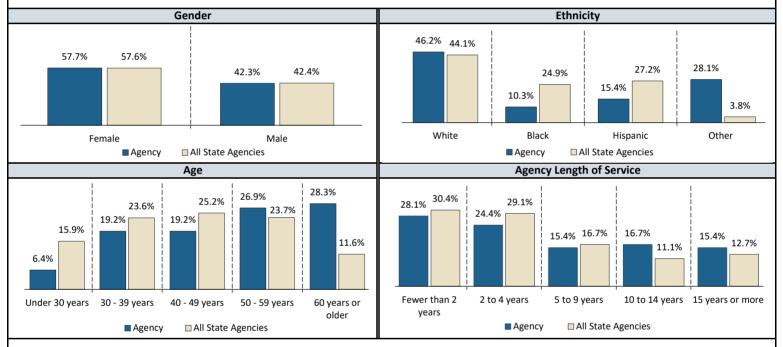

# Fiscal Year 2020 Workforce Demographics c

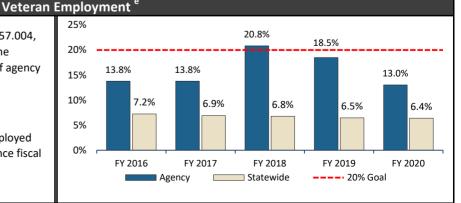
On average, employees at the agency were 51.5 years old and had 7.0 years of agency length of service. Of the agency's employees, 74.4 percent were 40 years old or older, and 52.5 percent had fewer than 5 years of agency length of service.
