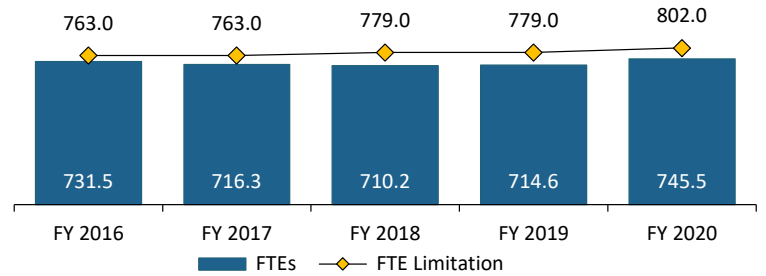
Based on information self-reported by the agency, the following items are noteworthy.

Full-Time Equivalent (FTE) Employees

The agency's full-time equivalent (FTE) employee limitation increased by 3.0 percent to 802.0 FTEs in fiscal year 2020 compared with fiscal year 2019. Compared with fiscal year 2016, the agency had an increase of 14.0 (1.9 percent) in the total number of FTEs.

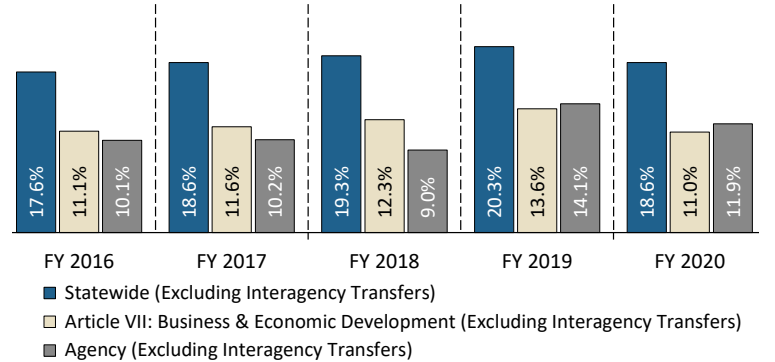
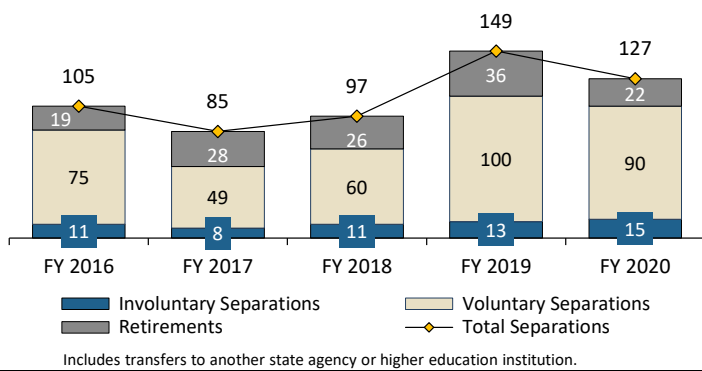

Employee Turnover ^a

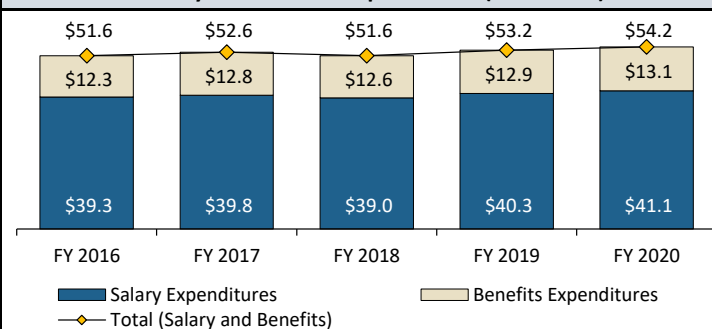
Excluding interagency transfers, the turnover rate within the agency (11.9 percent) was lower than the statewide turnover rate (18.6 percent) and higher than the turnover rate of Article VII agencies (11.0 percent) during fiscal year 2020. The fiscal year 2020 agency turnover rate including employees who transferred to another state agency or higher education institution was 16.8 percent.



Compensation Information ^a

The average agency salary of \$54,539 in fiscal year 2020 represented an increase of 3.5 percent compared with the average agency salary in fiscal year 2016. In fiscal year 2020, 70.3 percent of employees were paid below the midpoint of the salary range in which they were assigned. Total agency expenditures for salaries and benefits were higher compared with fiscal year 2016.

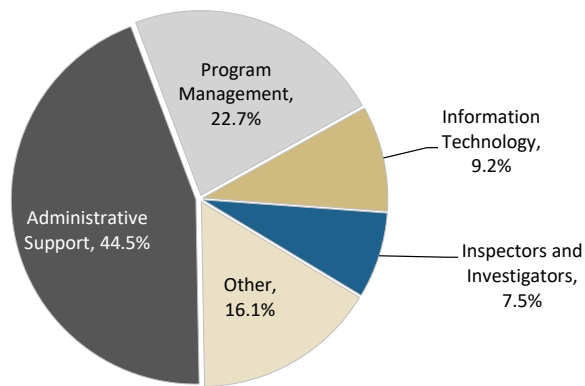

Agency Job Classifications

In fiscal year 2020, the majority (62.4 percent) of employees were classified in the following job titles: Customer Service Representative (28.1 percent), Program Specialist (10.8 percent), License and Permit Specialist (10.1 percent), Investigator (7.5 percent), and Manager (6.0 percent).

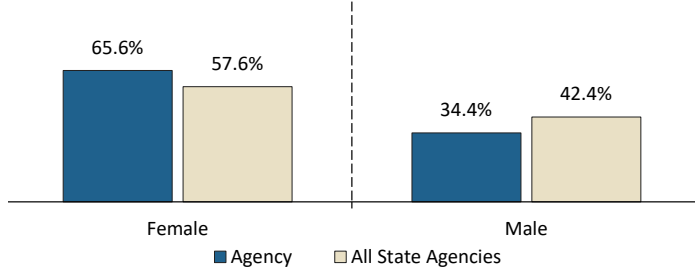
Classification Compliance Audit

As noted in the report titled *A Classification Compliance Audit Report on Information Technology Positions at Business and Economic Development Agencies* (SAO Report No. 20-701, January 2020), the agency correctly classified 38.6 percent of the 70 employee positions audited.

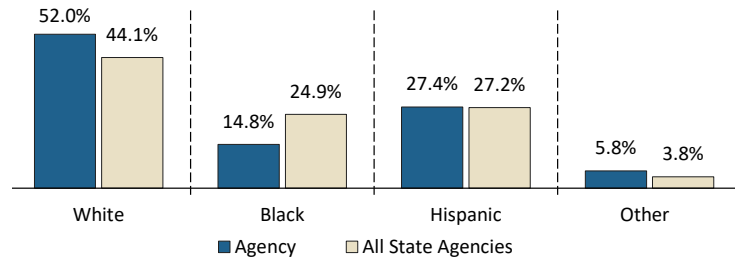
Fiscal Year 2020 Workforce Demographics ^{c e}

On average, employees at the agency were 48.5 years old and had 5.1 years of agency length of service. Of the agency's employees, 75.6 percent were 40 years old or older, and 50.9 percent had fewer than 5 years of agency length of service. The Employees Retirement System estimates that between fiscal years 2020 and 2024, 23.0 percent of the agency's workforce will be eligible to retire (based on fiscal year 2020 data).

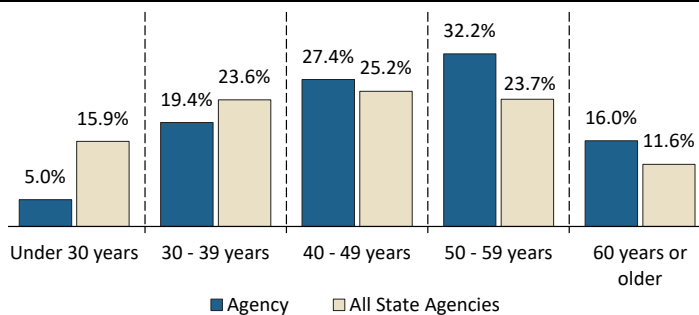
Gender



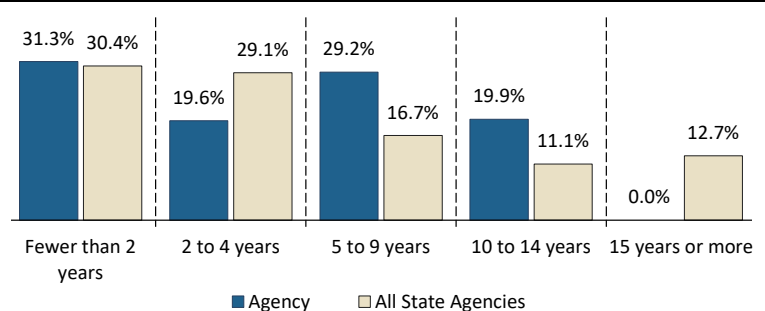
Ethnicity

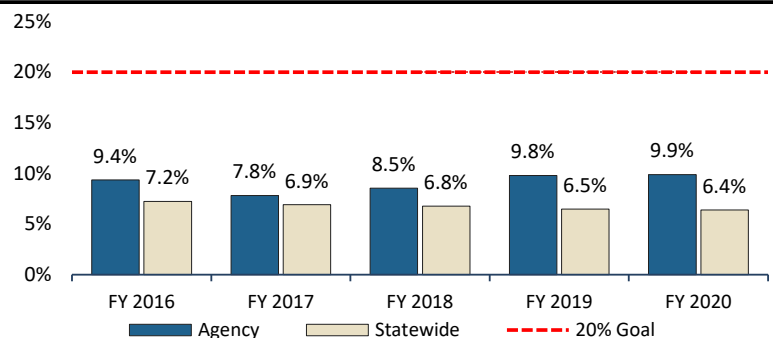

Veteran Employment ^f

Effective fiscal year 2016, Texas Government Code, Section 657.004, sets for state agencies a goal of employing veterans in full-time positions equal to at least 20.0 percent of the total number of agency employees.

In fiscal year 2020, the agency's total percent of veterans employed was higher than the statewide average and had increased since fiscal year 2019.
