

Full-Time Equivalent (FTE) Employees





Employee Turnover ^a

Excluding interagency transfers, the turnover rate within the agency (0.0 percent) was lower than the statewide turnover rate (22.7 percent) and lower than the turnover rate of Article IV agencies (16.7 percent) during fiscal year 2022. The fiscal year 2022 agency turnover rate including employees who transferred to another state agency or higher education institution was 0.0 percent.





Compensation Information ^a

The average agency salary of \$88,049 in fiscal year 2022 represented an increase of 15.6 percent compared with the average agency salary in fiscal year 2018. In fiscal year 2022, 66.7 percent of employees were paid below the midpoint of the salary range to which they were assigned. Total agency expenditures for salaries and benefits were higher compared with fiscal year 2018.




