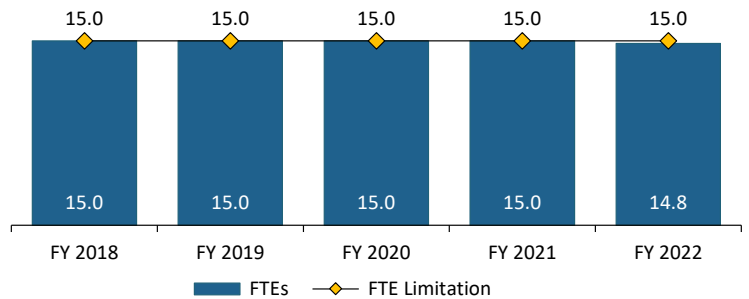

Based on information **self-reported** by the agency, the following items are noteworthy.

Full-Time Equivalent (FTE) Employees

The agency's full-time equivalent (FTE) employee limitation remained the same in fiscal year 2022 when compared with fiscal year 2021. Compared with fiscal year 2018, the agency had a decrease of 0.2 (1.3 percent) in the total number of FTEs.

FTEs Below/Above FTE Limitation

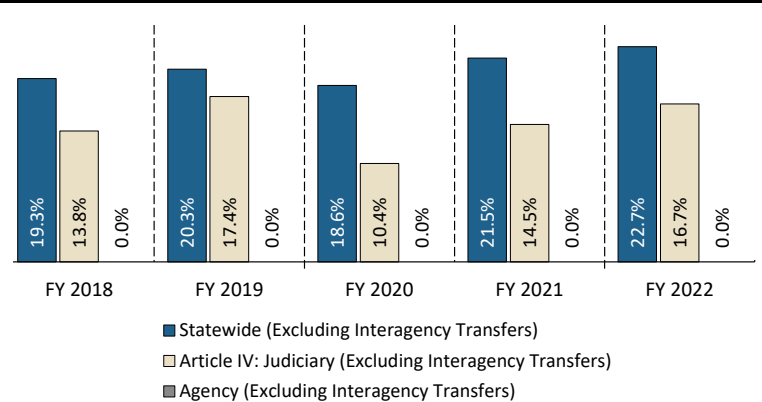

Employee Turnover ^a

Excluding interagency transfers, the turnover rate within the agency (0.0 percent) was lower than the statewide turnover rate (22.7 percent) and lower than the turnover rate of Article IV agencies (16.7 percent) during fiscal year 2022. The fiscal year 2022 agency turnover rate including employees who transferred to another state agency or higher education institution was 0.0 percent.

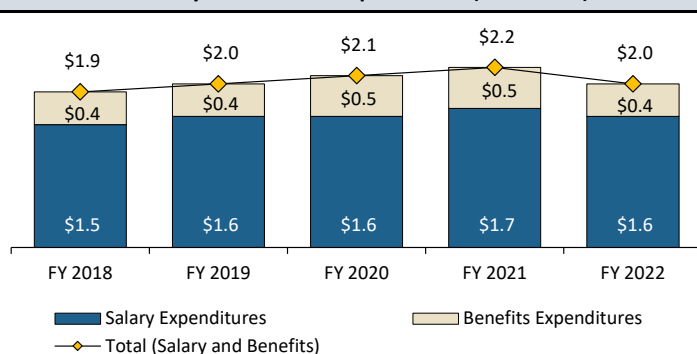
From fiscal years 2018 through 2022, the agency had no employee turnover.



Compensation Information ^a

The average agency salary of \$89,987 in fiscal year 2022 represented an increase of 0.8 percent compared with the average agency salary in fiscal year 2018. In fiscal year 2022, 16.7 percent of employees were paid below the midpoint of the salary range to which they were assigned. Total agency expenditures for salaries and benefits were higher compared with fiscal year 2018.

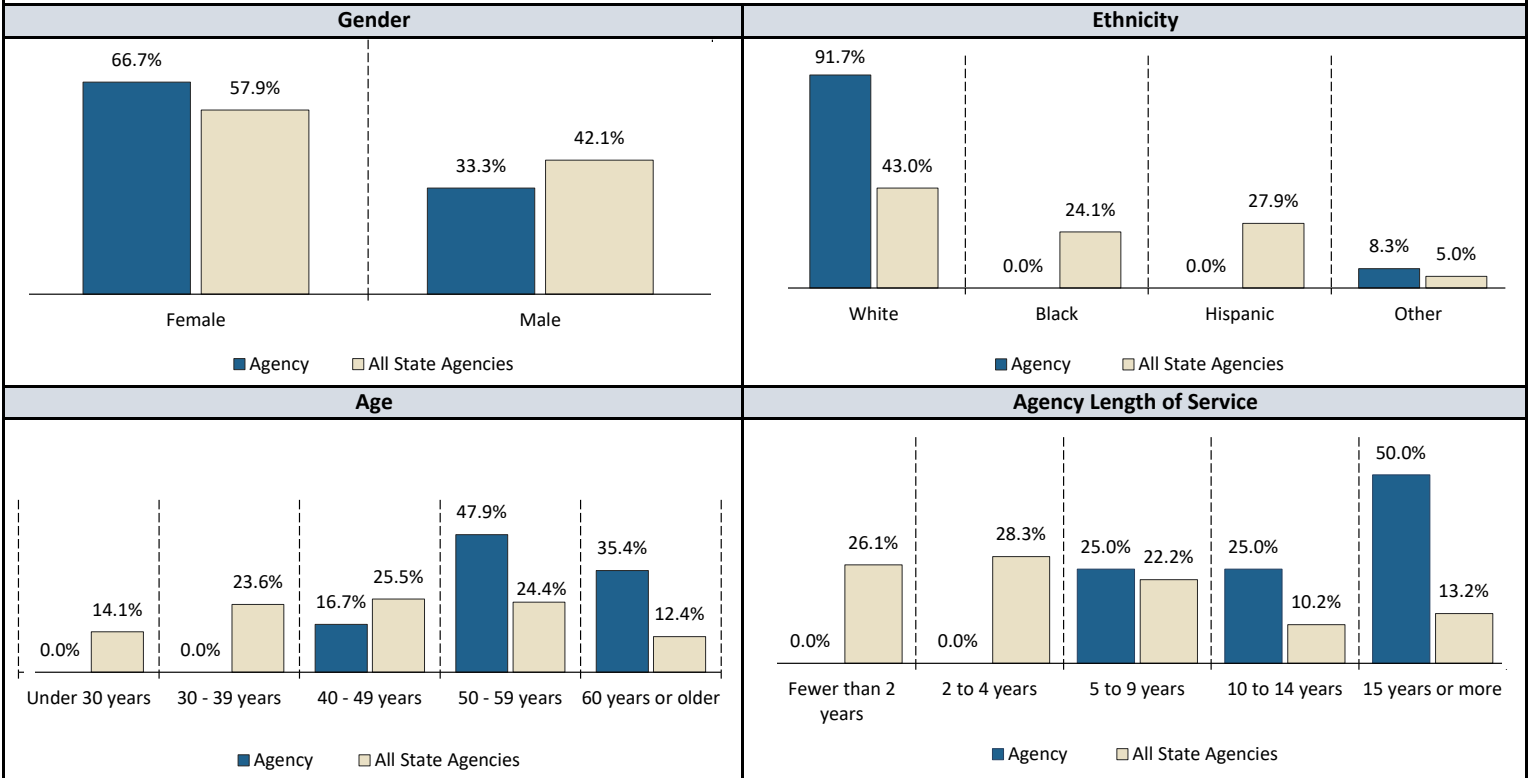

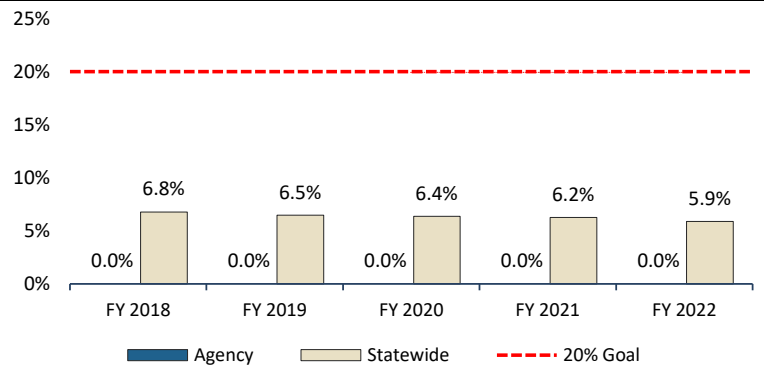

Veteran Employment ^d
