
Based on a review of information self-reported by the institution, the following items are noteworthy.

Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation decreased by 16.9 percent to 1,844.1 FTEs in fiscal year 2024 compared with fiscal year 2023. As of August 31, 2024, 102.0 FTEs were administrator positions. The institution's 7,358.1 total FTEs represents an increase of 1,376.5 (23.0 percent) in the total number of FTEs since fiscal year 2020.


In fiscal year 2024, 74.8 percent of FTEs were paid from non-appropriated funds and 0.9 percent of FTEs were paid from patient income. This was an increase of 30.3 percent in FTEs paid from non-appropriated funds and an increase of 33.2 percent in FTEs paid from patient income since fiscal year 2020. FTEs paid from non-appropriated funds and patient income do not count toward the FTE limitation.






Employee Turnover a

In fiscal year 2024, the total turnover rate for the institution was 16.3 percent. This was higher than in fiscal year 2023, when the total turnover rate was 15.2 percent. The turnover rate in fiscal year 2024 for administrators (12.9 percent) was higher than in fiscal year 2023; turnover for faculty positions (12.7 percent) was higher than in fiscal year 2023; and turnover for staff positions (18.1 percent) was higher than in fiscal year 2023.









Compensation Information b

Compared with the average salaries in fiscal year 2023, the average salary for staff employees increased by 3.6 percent, and for administrators it decreased by 1.3 percent. Compared with fiscal year 2020, salary and benefits expenditures increased by 20.3 percent.

In fiscal year 2024, the president's salary was \$1,570,786. This salary increased from fiscal year 2023, when the president's salary was \$1,470,893.



In fiscal year 2024, the institution used appropriated funds to pay for 73.0 percent of administrator merit increases and 31.0 percent of staff merit increases.


Of the institution's administrators, 95.5 percent were 40 years of age or older, and of the institution's staff employees, 60.1 percent were 40 years of age or older. The average length of employment at the institution for administrators was 12.0 years, and for staff employees it was 6.0 years.

Effective fiscal year 2016, Texas Government Code, Section 657.004, sets for higher education institutions a goal of employing veterans in full-time positions equal to at least 20.0 percent of the total number of institution employees.
